The annual meeting for 1989 was held at Kyushu University on 4-5 November. The following 22 papers were presented in all.

The annual meeting for 1990 was held at Kanto Gakuin University on 10-11 November. 1990 is the 40th anniversary of the foundation of the Society, and Professor Hiroshi Mizuta's special lecture, entitled "Adam Smith after 200 years" was delivered to commemorate it on the first day of the meeting. The common theme was not formally organised, but the defacto common theme this time was "Alfred Marshall" to commemorate the 100th anniversary of the publication of Marshall's Principles of Economics. The 20 papers presented were as follows:

The Essays in the History of Economic Thought edited by the Society to commemorate the 40th anniversary of its foundation will be published at the end of 1991 or early in 1992 at the latest.
