The Society for the History of Economic Thought, Japan Annual Meeting 1982.

The annual meeting for 1982 was held at Toyo University in Tokyo on 6-7 November. The common theme of the annual meeting was again 'Advanced countries-underdeveloped countries problem in the history of economic thought on which the following three papers were read:

1. Michael Chevalier's views on the New World (Takashi Ueno)
2. A.F. von Haxthausen on German agricultural administration (Mitsuo Naganawa)
3. A.I. Gertsen on socialism (Eiichi Hisen)

In addition, the following 14 papers were presented in all:

1. B. Mandeville on civilized society (Kiyofuji Yahata)
2. Proudhon on credit reform (Etsunori Saito)
3. The publication of Wealth of Nations and the revision of Theory of Moral Sentiments (Nobuyoshi Kawashima)
4. On the formation of the conception of double character of labour in Marx (Takeo Shibata)
5. The Significance and analytical viewpoint of James Mill's History of British India (Michihiro Otonashi)
6. Adam Smith on division of labour (Takeo Nakatani)
7. The French Revolution and the navigation act (Koichi Yamasaki)
8. The logic of Market and the understanding of society in J.B. Say (Keiko Kurita)
9. Yasuma Takada's views on poverty, national life, and the significance of productive forces (Ryoji Kaneda)
10. Economic policy controversy in Germany in the end of the 19th century (Shinichi Tamura)
11. Capital formation and crisis in Classical school, centering on the Ricardo-Malthus controversy (Toru Matsuhashi)
12. The formation of Keynes' General Theory (Toshiaki Hirai)
13. How to refute Malthus' Principle of Population (Yoshiro Tamanoi)
14. The introduction of the economics of Keynes into Japan from Indian Currency and Finance to the end of the World War II (Tadashi Hayasaka).

Professor Masao Hamabayashi, Hitotsubashi University was elected as the next president with the other directors at the general meeting of the conference. His two year presidency will begin from April 1983 to succeed Professor Kazuo Mazane.

The common theme of the annual meeting 1983 will be tentatively 'Karl Marx' in commemoration of the 100th year after his death.

As to the regional activities of the Society since the meetings previously reported are only one meeting of the Kansai branch which was held on 25 September at Okayama University. Three papers were read there: (1) T. Hatori and S. Hollander on the Ricardo's corn model (Hiroji Nakamura); (2) The logic of 'circulation process of capital' in the theory of capital accumulation (Koichi Shimizu); (3) On the formation of Bohm-Bawerk's theory of capital (Kiichiro Yagi).

#### Recent Activities of the Society for the History of Economic Thought, Japan.

The recent activities of Japan HET Society since the meeting previously reported were those by the four regional branches.

##### The Kanto branch

On 4 June 1983 at Rikkyo University where two papers were read: (1) 'The discovery of social surplus and Marx' (Shigeo Abiko); (2) 'A report on the Marx centenary conference after his death in Linz - Centering on Jurgen Rojahn's paper, "Problems of Economic and Philosophical Manuscripts of 1844" - ' (Ryuji Yamanaka).

##### The Kansai branch

On 22 January 1983 at Osaka Prefectural University where two papers were read: (1) 'A study of Malthus' theories' (Toshinobu Yanagida); (2) 'The significance of theory of crisis in modern Capitalistic Society' (Aiko Moyoshi).

On 28 May 1983 at Shiga University where three papers were read: (1) 'The significance of the digression concerning the variations in the value of silver in the Wealth of Nations' (Kumihiro Watanabe); (2) 'Schumpeter on the future of Capitalism' (Tadao Ohno); (3) 'Marx and Engels on peasantry' (Ataru Hoshino).

##### The Seinai branch

On 29 and 30 January 1983 at Kumakoto University of Commerce where four papers were read: (1) 'J.E. Meade on the Theory of economic growth' (Ken Shimagami); (2) 'On the definition of the value of labor power' (Takashi Morioka); (3) 'Ricardo's logic of criticism against the cost-of-production theory' (Hiroji Nakamura); (4) 'Sismond's theory of crisis and Marx' (Mitsutaka Nakamiya).

On 12 March 1983 at Kyushu University where the two public lectures were delivered to mark the centenary of Marx's death under the joint sponsorship with the Western Japan branch of the Society for Economic Theory: (1) 'My Marx study-centering on the views of alienation' (Mitsuki Soeda); (2) 'My Marx study-centering on the reproduction theory' (Kohjiro Takagi).

##### The Tohoku branch

On 18 June 1983 at Tohoku University where two papers were read: (1) 'On the history of astronomy and moral philosophy in Adam Smith' (Kazuo Endo);
